MEMORANDUM OF AGREEMENT

BY AND BETWEEN

THE GEORGIA ENVIRONMENTAL FINANCE AUTHORITY

AND

CITY OF AUBURN

DO NOT DATE THIS PAGE **This Memorandum of Agreement** (hereinafter "Memorandum") for the WaterFirst Program is made and entered into effective December 31, 2023, by and between the Georgia Environmental Finance Authority (hereinafter "GEFA") and the **CITY OF AUBURN** (hereinafter "Designee") (each a "Party" and collectively the "Parties"). All Parties agree to enter into this cooperative arrangement to maintain the Designee as a WaterFirst Community for a five-year period.

ARTICLE I Benefits and Activities

The benefits associated with the WaterFirst Community designation are listed below. The Parties intend to explore opportunities under each benefit.

- 1. Five years of resources, tools, and support provided by GEFA to help meet water management goals.
- 2. Statewide recognition for being environmental stewards.
 - Listed on GEFA's website.
 - Listed on WaterFirst outreach fliers.
 - Listed on WaterFirst presentations.
 - Provided two road signs and authorization to use the WaterFirst logo and brand.
- 3. Access to WaterFirst peer network and resources.
- 4. Invitation to workshops addressing critical water stewardship issues.
- 5. A 1 percent interest rate reduction on GEFA loans.
- 6. Annual eligibility for Georgia Department of Community Affairs Community Development Block Grants for water-related projects.
- 7. Priority for 319(h) grant funding administered by the Georgia Environmental Protection Division.

ARTICLE II WaterFirst Community Responsibilities

The Designee agrees to the following responsibilities to remain in good standing and to retain its WaterFirst Community designation:

- 1. Continue achieving environmental excellence in all areas of water resource management.
- 2. Enhance effective maintenance practices.
- 3. Improve customer service.
- 4. Participate in a WaterFirst Program peer review.

- 5. Provide support and encourage staff participation in at least one WaterFirst function during the five-year term.
- 6. Maintain eligibility as a qualified local government by having an approved Comprehensive Plan and Service Delivery Strategy.
- 7. Continue efforts to conserve water with shallow well shower installations at the beach entrances.
- 8. Explore opportunities for potable water savings, such as reclaiming water for use in the sludge press at the Wastewater Plant.

ARTICLE III Amendments

This Memorandum represents the entire agreement between the Parties. An amendment can be added to this Memorandum if it is presented in writing and signed by all Parties.

ARTICLE IV Name and WaterFirst Community Logo/Banner/Pins or Similar Items

GEFA agrees to allow the use of the WaterFirst Program logo and brand items by the Designee on/for any WaterFirst Program activities, grant applications, and related activities. The Designee acknowledges receipt of the WaterFirst Program logo and brand items and any additional products and agrees to use these items only for activities related to, or affected by, the WaterFirst Program.

ARTICLE V Term and Termination

The Memorandum is effective as dated above and expires December 31, 2028. GEFA has the authority to terminate this agreement if the Designee does not maintain compliance with program requirements, or if the Designee falls out of compliance with its Georgia Environmental Protection Division permits. The Designee will receive a written notice that its designation has been rescinded and GEFA will apply the standard interest rate upon any new loan agreement subsequent to the termination. In this eventuality, the Designee agrees to discontinue using the logo and remove the WaterFirst signs.

This Memorandum constitutes the entire agreement and understanding between the Parties hereto and replaces, cancels, and supersedes any prior agreements and understandings relating to the subject matter hereof; and all prior representations, agreements, and undertakings between the parties hereto with respect to the subject matter hereof are merged herein.

RE: Recommendation of Contractor for Phase A of RWSP Piping

This contract will construct the pipeline and pump station to transfer raw water from Rock Creek Intake #1 to the Auburn Drinking Water Treatment Plant. This project will withdraw the water from Rock Creek and transfer it to the under construction drinking water treatment plant (DWTP). Intake #1 is located where Parks Mill Road crosses the creek. A location map is attached.

To select a contractor for this project, advertisements were placed in the Barrow County Main Street News, Auburn's Bids Website, and Georgia Procurement Registry. Several Companies were interested and attended the mandatory pre-bid conference. On the bid due date of 11/20/23 only two companies submitted proposals: Griffin Bros. Inc., and Strack Inc.. The certified bid tabulation is attached. The Project was bid as a design-build type project with a stipulated guaranteed maximum price for three phase. Phase A is the pipeline and pump station connecting Rock Creek Intake with the Auburn DWTP. Phase B is the pipeline connecting Rock Creek Intake #2 with the RWSP. Phase C is the pipeline connecting the RWSP with the Mulberry River and the Winder DWTP.

The proposals were review and the contractors interviewed. After the interviews it was determined to award the contracts on the basis of low bid since both contractors were well qualified for all phases. Griffin Bros., Inc. was the low bidder for Phase A and Strick, Inc. was the low bidder for Phase B & C. This memo is about awarding only Phase A because it is needed first and the RWSP is not full of water at this time.

Griffin Bros' original proposal was \$2,276,040.62. After the interview and design-build conference the Stipulated Guaranteed Maximum Price was amended to \$2,283,094.19. The changes coming from the design-build conference were: a. Transfer 40 feet of 12" DIP pipe from Phase B to Phase A. b. Substitute 16" DIP with 16"HDPE. c. Add 372 feet of water sampling line. d. Add 150 feet of chain link fence.

Griffin Bros. has been in business since 1968 and is a Georgia licensed utility contractor, #UC300109. They did about \$12,000,000 of business in 2022 and 2023 and have 25 full time employees. Their bonding company, Great American Insurance Company, is listed on the US Treasury's approved bonding companies list. We contacted Great American Insurance Company and confirmed that yes they would bond Griffin Bros. should the contract be awarded to Griffin Bros. The Stipulated Guaranteed Maximum Price contract include an owners contingence of \$204,761.81. Their list of clients include City of Gainesville, City of Lavonia, City of Commerce, Town of Braselton, Oconee County of BOC, Madison County Industrial Authority, Banks County Commissioner, Forsyth County Department of Water and Sewer, City of Winder and the City of Crawford.

We recommend that Rock Creek Intake Piping Phase A contract be awarded to Griffin Bros. Inc. of 105 Griffin Drive, Maysville, GA 30558 with the Stipulated Guarantee Maximum Price of \$2,283,094.19 and that the Council Authorize the Mayor to sign said contract upon approval as-to-form by the City Attorney.


