### RESIDENTIAL AND COMMERCIAL EXCLUSIVE SOLID WASTE AND RECYCLING COLLECTION AND DISPOSAL PROGRAM

This addendum is being issued to address questions submitted on RFP 20-004.

1. What are the current rates for all services please?
  - a. Regular residential \$16.19/Senior \$13.79 monthly
2. Please verify if it is the City's intent that the contractor do the residential billing.
  - a. Correct.
3. Please provide the annual tons collected for residential trash. Please clarify if this includes bulk and yard waste.
  - a. 1,625.44 approximately – and yes.
4. Please provide the annual tons collected for residential recycling.
  - a. a. 250.88 approximately
5. Please clarify what is required in Section 2.1 (contractor maintained collection site).
  - a. This just means that the contractor will be responsible for the site where the disposal of recycling items are handled.
6. How often is bulk required to be picked up?
  - a. Weekly
7. How often is Yard waste required to be picked up?
  - a. Weekly
8. Please clarify what type of recycle compensation is the City requesting in Section 2.1?
  - a. None
9. Can you provide info on how many of the commercial units will initially be under the grandfather rule stated in Section 2.2?
  - a. Currently, the only commercial account is for the City of Auburn.
10. Does the City require a certain size recycle container?
  - a. At least 18 gallons
11. Does the City have a pricing page/matrix form for the submittal?
  - a. No. Please use PROPOSAL DOCUMENT FORM listed in section 8.2
12. Are there any commercial business' that receive waste collection in a residential trash cart instead of a commercial front end or roll off container. If so, how many businesses.
  - a. Just the City of Auburn, and we have 7.
13. The weekly volume limit per household for yard waste is not provided. Please provide an example such as up to six-yard waste bags or four bundles of limbs per household weekly. The size and weight restrictions were provided, we need to know the volume limit per household weekly.
  - a. The current contract limits to 12 bags per week.
14. Section 4.7 of page 14 states that "on publicly –owned roadways accessible to standard waste collection vehicles". The question that we are seeking an answer to is whether or not a small collection vehicle such as a pickup truck is used to provide collection to any households, and if so how many? Is a "standard waste collection vehicle" referring to a tandem axle commercial motor vehicle only.

- 15. How many households currently receive back door service.
  - a. Approximately 10%
- 16. Please provide the current number of households billed monthly for residential service.
  - a. 2,227
